CIRCULAR

Subject: Implementation Of online declaration of Immovable Property Return (IPR) through SPARROW portal for ESIC officials/Officers-reg.

I have been directed to invite a reference to the Circular dated 17.01.2020 on the above cited subject and the subsequent communications in this regard from time to time. In this regard it is informed that the Central Vigilance Commission(CVC) also monitors the progress of the filing of the Annual Immovable Return(AIPR).

It has been conveyed by the CVC that the prescribed time limit for filing of the AIPR has already lapsed. Thus it has been directed to ensure 100% compliance of the filing of the AIPR by employees/officers of ESIC latest by 30.11.2020 and inform the CVC. In case of non-filing of the AIPR by the concerned officer/officials by 30.11.2020, appropriate disciplinary action is to be initiated against them.

Hence, all officers/officials (All Group-A & B and Group- C officials up to the rank of SSO and equivalent/above) of the ESIC are requested to comply with the instructions of the CVC. The concerned Competent Authorities are requested to ensure the compliance and intimate the name of officers/officials (at email id manisha.shukla@esic.nic.in) who have not filed the AIPR for the year ended 31.12.2019 and liable for the initiation of the appropriate disciplinary action against them. Name of all such officers/officials may be conveyed to Vigilance Branch.
