No. F-1-4-2020-A-XVI.—In exercise of the powers conferred by Section 112 of the Factories Act, 1948 (No. LXIII of 1948), the State Government, hereby, makes the following amendment in the Madhya Pradesh Factories Rules, 1962, namely:—

AMENDMENT

In the said rules,-

- 1. after rule 123, the following rule shall be inserted, namely:—
 - "123-A. Third Party Certification.—(1) Labour Commissioner, may recognize any person or institution, who is recognized by Chief Inspector of Factories as Competent Person or Institute, possessing required qualification under rule 123 to inspect dangerous machines, hoist and lift, lifting machines and lifting tools and pressure vessels, as third party certifier for third party inspection and certification of factories as prescribed in this department's Notification No. 954-02-2020-A-16, dated 5th May, 2020 published in Madhya Pradesh Gazette, Extra-ordinary. The person/institution who is willing to perform such function shall have to apply online to the Labour Commissioner for recognition as third party certifier in Form 36-B or 36-C as the case may be.
 - (2) Labour Commissioner on receipt of application in prescribed form under sub-rule (1) shall register such application and after being satisfied regarding qualification and experience shall recognize as third party certifier in Form 37-A or reject for the reasons to be recorded in writing within a period of 60 days.
 - (3) Certificate of recognition as third party shall be issued for such area and for such period as may be specified in the certificate.
 - (4) The Labour Commissioner, if he has reason to believe that a recognized person/institution has rendered himself unfit for any reason, to be recorded in writing, may revoke person/institution recognized for third party certification after giving an opportunity to the third party certifier of being heard.

(5) Any person recognized for third party certification shall not be deemed to be a public servant within the meaning of the Indian Penal Code, 1869 (45 of 1860).

Explanation.—For the purpose of this rule, an Institution includes an organization.".
