No: GHR/2020/158/IBA/112020/502190/M3: The following draft of rules which is proposed to be issued under section 29 of the Boilers Act, 1923 (5 of 1923) is published as required by sub-section (1) of section 31 of the said Act, for information of all persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government of Gujarat on or after the expiry of thirty days from the date of publication of this draft notification in the *Official Gazette*.

2. Any objection or suggestion which may be received by the Additional Chief Secretary to the Government of Gujarat, Labour and Employment Department, Sachivalaya, Gandhinagar from any person with respect to the said draft rules on or before the expiry of the aforesaid period will be considered by the Government.

Boilers Act, 1923. No. GHR/2020/158/IBA/112020/502190/M3 :- In exercise of the power conferred by section 29 of the Boilers Act, 1923 (5 of 1923), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Boiler Rules, 1966 namely:-

1. These rules may be called the Gujarat Boiler (2nd Amendment) Rules, 2020.
2. In the Gujarat Boiler Rules, 1966 (hereinafter referred to as the "said rules") in rule 13 for the word "areas" , the word "region" shall be substituted.
3. In the said rules, rule 38 and 45 shall be deleted.
