Madam/Sir,

In continuation of the above letters dated 23.12.2020 & 11.01.2021 issued by this office on the above captioned subject and pursuant to clarification received from GeM, all user units are requested to procure drugs from CPSU firms through GeM Portal following the below mentioned procedure:

- Purchase order shall be placed directly to the respective registered CPSU firm/s (Direct Procurement) as per their requirement irrespective of order value. This process is already enabled on GeM Portal. No separate Comparison/Bidding/Reverse Auction needs to be done for procurement of drugs through CPSU firms on GeM Portal.
- 2. In adherence to the Pharmaceuticals Purchase Policy (PPP) for products of CPSEs and their subsidiaries issued by Government of India, Ministry of Chemicals & Fertilizers, Department of Pharmaceuticals, preferably, Purchase Order for quantity of respective item should be equally placed at each instance amongst all CPSU firm/s registered for item on GeM.

Madam/Sir,

In continuation of above letter dated 23.12.2020, I am directed to inform the duly approved guidelines as below for procurement of CPSU drugs which are Not Supplied or are Part Supplied by CPSU firms under Pharmaceutical Purchase Policy through GeM Portal:

- Drugs which are Not Supplied / Part Supplied by CPSU firms under PPP through GeM Portal, will be procured through DG ESIC RC 147 & 147A, valid upto 29.08.2021 & 29.03.2022 respectively, issued as backup RC for CPSU drugs or any other RC released in future as backup RC for CPSU drugs.
- Procurement through DG ESIC RC 147 & 147A is subject to documenting the Non-Supply/Part Supply by generating NA report on GeM/Incident report/ any other documentary evidence before proceeding for procurement through DG ESIC RC 147/147A or any other RC released in future as backup RC for CPSU drugs.
- 3. It is also mandatory that all user units should determine Re Order Level, Buffer Stock and consider lead times for delivery as per Terms & Conditions of GeM / Rate Contract, for maintaining adequate stock for smooth delivery of services to the patients.
