ORDER:-

In the references 1st and 2nd read above, the Government of India has requested the States to examine various Acts and Regulations in the States, to rationalize and simplify the existing process of implementation of the same, in order to minimize the burden of regulatory compliance to the industry for Ease of Doing Business.

- 2. In the circumstances reported by the Director of Factories, Telangana, Hyderabad in the letter 6th read above, Government after careful examination of the matter hereby decided to grant exemption from the applicability of certain provisions of the Factories Act, 1948 and Telangana Factories Rules 1950, subject to certain conditions to simplify / minimize the regulatory compliance burden of the industry.
- 3. Accordingly, the following notification shall be published in the Extraordinary issue of the Telangana State Gazette, dated:22.02.2021.

NOTIFICATION

In exercise of the powers conferred on the Government under Section 8 and 9 of Factories Act, 1948 grant exemption from applicability of certain provisions under Factories Act 1948 and Telangana Factories Rules 1950 as mentioned in Annexure appended to this order, subject to the condition that the occupier shall submit self certification / third party certification through online as mentioned in reference 5th cited to minimise the compliance burden on factories until further orders. The provisions mentioned in the annexure shall be deemed to be complied by the factories covered under Factories Act, 1948 on receipt of such self certification / third party certification from the occupiers of factories and there shall not be any inspection/verification of these factories except in case of complaints and accidents. The inspections shall be authorised by Director of Factories in such cases.

4. The Director of Factories, Telangana, Hyderabad shall take further action in the matter accordingly.
