Subject: Waiver/Reduction on concession fees payable by PPP partners of Fair Price Diagnostics & Dialysis units on ground of COVID 19 Pandemic.

Dear Sir/Ma'am,

Department of Health and Family Welfare, Govt. of West Bengal has established PPP projects for Fair Price Diagnostic & Dialysis Services at different tiers of hospitals across the state. Currently, 150 Fair Price Diagnostic & Dialysis units are functional in 59 hospitals across the state. Government pays service amount to the PPP partners for providing services to the government referred cases as per agreement conditions. Private partner pays concession fees to the authority (RKS).

Due to COVID 19 pandemic situation and lock down restriction in the country the no. of patient's footfall has declined during the lockdown period. Owing to lockdown restriction, PPP partners have requested to the department to waive off the concession fees off due to decline in patient's footfall.

Accordingly, after due consideration of the whole situation the department has agreed to consider the lockdown restrictions due to COVID 19 pandemic as Force Majeure, as per provisions of Article 12 of the concession agreement. Based on the situation and as per concurrence of the Finance Department, the department has now decided to accord approval of waiver/reduction of concession based fees on the following terms and conditions:-

 The concession fees will be waived off/reduced for the 1st quarter (Apr 2020 to June 2020) of FY2020-2021 on account of lockdown restriction due to COVID 19 pandemic as per the followings slabs:

4	Above 75%	Full concession fees to be paid by the PPP partners as per the provisions of the concession agreement for 1 st quarter (Apr 20 to Jun 20) of FY2020-21		

2. The concession fee will be fully waived off for those units which are located in declared COVID 19 hospitals, where there is no general service at present and till general services are established there or patient footfall crosses 40 % compared to last financial year (FY 2019-20), whichever is earlier. For the purpose of calculation, the account of section of the hospital will compare the average monthly patient footfall in FY 2019-20 (April to March) vis a vis the patient footfall of the remaining quarters of FY 2020-

- 2021 and FY 2021-22 as where applicable. The applicable slab of discount of concession fees shall be as per table in point 1 above.
- PPP partners who have already paid the concession fees during this period (Apr 2020 to June 2020 of FY 2020-21) will be allowed to adjust the calculated waiver/reduction amount from the future concession fees payable by the PPP partners.
- 4. In case any PPP partners have not paid the concession fees during these period (Apr 2020 to June 2020 of FY 2020-21), they will pay the same after adjustment of the waiver/reduction amount as per the slab mentioned above.
- 5. In some cases, the quarter for calculation of concession fees may not match with the quarter mentioned for exemption period (Apr 2020 -June 2020). In such cases, the concession fees will be calculated month wise and accordingly, the waiver/reduction amount will be calculated as per the slab mentioned in the above table.
- 6. Concession fees are payable at fixed quarterly quoted amount or 20% of gross total income generated in that quarter whichever is higher. Concession fees should be calculated based on approved service charges as per existing G.O. However the charges incurred towards procurement of Contrast material, Dialysis Kits and any other medicines or consumables required to complete the procedure as billed by the partners will not be considered while calculation of concession fees.
- 7. There shall not be any further waiver/reduction of the concession fees beyond Apr 2020 to Jun 2020 period, except for dedicated COVID 19 hospital.
- 8. Cost of CAMC, electricity as per the actual consumptions will need to be paid by the PPP Partners and the same will not be exempted on the ground of lockdown restriction.
- All other terms and condition of the concession agreement remain unchanged and the private partner shall continue to provide services and pay the concession fees, electricity bills and charges for CAMC without fails as per the provisions of the concession agreement.
- 10. For all those units which were operational during April 2020 to June 2020 under PPP model and later the agreement was terminated with approval of the department, will be eligible for the waiver/reduction as applicable. In such cases, the calculated amount of the waiver/reduction may be refunded to the respective PPP partners from the available concession fees deposited in RKS for the same services.

Slab wise waiver/reduction rates with the name of the PPP partner and hospital is provided under Annexure I of this letter for your ready reference. The account section of the hospital will calculate the actual waiver/reduction amount of the concession fees based on the mentioned slab. Accordingly, the hospital authority will intimate the PPP partners for necessary payment or adjustment, if already paid as per the direction above.

Upon finalization of the waiver/reduction amount based on above guidelines, the hospital authorities will submit a report as per Annexure II duly signed by the accounts officer and counter signed by MSVP/Superintendent for necessary approval of the department. After due approval of the department, the hospital authorities will take necessary action for adjustment of the waiver/reduction amount.
