Reference captioned subject, please refer to OM's No. 6/18/2019-PPD dated 24.04.2021
& 27.05.2021 issued by Department of Expenditure, Ministry of Finance on the above cited
subject (both OM's enclosed).

In regards to relief operations for COVID-19 Global Pandemic, Ministry of Finance,
Department of Expenditure, Govt of India has granted a specific exemption of procurement
through GeM Portal for Covid related items for purchases to be made under Rule 166 and Rule
204 of GFR. This exemption is upto **30.06.2021**.

During this COVID 19 pandemic, all concerned Deans/MSs must ensure to provide
medical care to all IP's/ beneficiary by timely procurement and maintaining sufficient stock of
Covid related items like drugs / Oxygen Concentrator / Oximeter / Gloves / PPP kit / Mask /
Hand sanitizer / nebulizer etc.

All concerned Deans/MSs must ensures procurement shall adhere to procurement policy
guidelines, instructions of Government of India issued from time to time and recording of
justification by the Competent Authority with due concurrence from Local Finance & Accounts.
Due diligence and financial propriety should be followed while exercising these emergency
powers.
