Sir/Madam,

As you are aware, ESI Corporation during its 182nd meeting held on 20 August, 2020 has decided that ESIC may be reimbursed by respective State Governments for non ESI beneficiaries admitted in ESIC dedicated Covid hospitals, as per nominal reimbursement rates prevailing in the State for treatment of Covid and related illnesses in private hospitals.

Accordingly, information was earlier sought in prescribed proforma from ESIC dedicated Covid hospitals vide hqrs letter no. pt U-13/14/38/2020/Med I(ESIC/SC) dated 18.03.2021(copy enclosed).

In view of above, if your hospital has provided Covid treatment services to non ESI beneficiaries as dedicated Covid hospital, you are requested to expedite the reimbursement of such expenditure by State Government and also submit the updated status as per prescribed proforma through email at <a href="med1-hq@esic.in">med1-hq@esic.in</a> latest by 25th June 2021.

Further, if your hospital has never been designated as Dedicated Covid hospital, the same may also be informed to this office.
