In exercise of the powers conferred under Section 22(5) & 23(8) of APSADA Act, 2020 the Governor of Andhra Pradesh hereby makes the following amendment to the "Date of commencement of Endorsement / License issuance process for Aquaculture Farms and Aquaculture Business Operations under APSADA Act, 2020, issued in G.O.Rt.No.28, AHDD&F (Fish) Department, Dt: 05-02-2021.

### **AMENDMENT**

The Date of commencement of Endorsement / License issuance process for Aquaculture Farms and Aquaculture Business Operations under APSADA Act, 2020, is 01.07.2021 instead of 5.2.2021, for applying for the Licenses within 4 months as per the provisions contained in Section 22(5) and 23 (8) of the APSADA Act, 2020 i.e., by 31.10.2021" and also to uphold the validity of endorsement / Licenses already issued to aquaculture farmers during the period since 5.2.2021 as ordered in the G.O. 3<sup>rd</sup> read above.
