ORDER:

Government of India directed to focus in Phase-II on decriminalisation, identification of redundant laws and rules, regulatory impact assessment and use of technology. The Department identified 362 Burdensome Compliances under various Enactments/Notifications.

2. In the reference 1st read above, the Special Chief Secretary, Industries & Commerce, Government of Andhra Pradesh has reported that the timelines for completion of uploading of all regulatory compliances, action plan on reducing burdensome compliances under various Acts/Rules administered by this Department and closure of action plan on the DPIIT regulatory compliance portal www.eodbrcp.dipp.gov.in is 15th August, 2021. The LFB&IMS Department have identified fifty-one (51) burdensome compliances for phase-I and fifteen (15) burdensome compliances for Phase-II. Closure of Phase-I and Phase-II action plans are pending. During Cabinet Secretary's review meeting held on 08th July, 2021, we have committed to abide by the date of 15th August 2021 for completion of phase-II action plans as set by DPIIT and requested to initiate closure of action plans in the DPIIT Regulatory Compliance Portal at the earliest.

3. In the reference 2nd read above, the Special Commissioner of Labour, Andhra Pradesh has furnished a proposal for introducing Auto renewals of Registration under the Andhra Pradesh Shops and Establishments Act, 1988 after submission of self certification and payment of fee online instead of exemption from renewal of Registrations.

4. After careful examination of the request of the Special Commissioner of Labour, the Government of Andhra Pradesh have decided to introduce Auto renewals of Registration under the Andhra Pradesh Shops and Establishments Act, 1988 after submission of self certification and payment of fee online instead of exemption from renewal of Registrations under the Andhra Pradesh Shops and Establishments Act, 1988 in the State.

5. Accordingly, the following notification will be published in the Extra-ordinary issue of Andhra Pradesh Gazette.

In exercise of powers conferred under sub-section 4 of section 73 of the Andhra Pradesh Shops and Establishments Act, 1988 (Act No.20 of 1988) the Government hereby amend in terms of regulatory impact assessment and use of technology, section 4 read with rules 3(4), 3(5), 3(6) and 3(7) of the Andhra Pradesh Shops and Establishments Act, 1988 and Rules, 1990, Auto renewal of Registration under Shops and Commercial Establishments on submission of self certification and payment of fee online introduced instead of exemption from renewal of Registrations under the Andhra Pradesh Shops and Establishments Act, 1988 in the State.
