Sub:- Advisory on disposal of C&D waste through authorised C&D Plants to mitigate dust from construction sites - regarding.

Madam/Sir.

As you are aware that construction/demolition activities in NCT of Delhi have to be undertaken only after ensuring the Dust Mitigation Measures on site.

Given the directions of the Commission for Air Quality Management in the National Capital Region and Adjoining Areas and for effective implementation of the different guidelines issued from time to time for control of dust emissions from construction sites, Chief Secretary Delhi convened a meeting on 05.10.2021.

In the meeting it was decided that government departments may ensure that construction/demolition project proponents or developers shall submit an agreement with authorized C&D plants for proper disposal of C&D waste to be generated by them, before approving maps, and granting permissions for construction /alteration. This is to ensure safe and scientific disposal of construction and demolition waste arising from new construction /alteration in buildings /renovation.

Moreover, construction agencies and departments undertaking construction and demolition may not release payment till the contractor submits mandatorily a certificate to the effect that the C&D waste produced from the site has been delivered to the authorized C&D plant. The quantum of waste generated and deposited should be captured in the certificate.
