Sub: Installation of telemetry devices on Liquid Medical Oxygen storage vessels - regarding.

Please refer to the discussions held in the V.C. meeting chaired by Additional Secretary, DPIIT on 02/11/2021 with all the Liquid oxygen manufacturers and PESO.

In the meeting, a need for provision of telemetry devices on LMO storage vessels installed in the hospitals as well as in the premises of refillers and LMO manufacturers was discussed. The installation of telemetry devices will help the management of hospital to take timely decision about indenting LMO and also help LMO supplier to prioritize the supply of LMO among their customers i.e. hospitals and refillers which in turn will reduce the turn around time of LMO transport tankers. This will also help Oxygen monitoring control rooms to have direct access to the oxygen storage levels of all LMO storage vessels in the country during the crisis times.

In view of the above, all LS-1A licensees (hospitals/refillers/LMO manufacturers) who have been granted licenses for storage of LMO in bulk by PESO under SMPV(U), Rules, 2016, shall install the telemetry devices on LMO storage vessels at the earliest and report in this regard incorporating the license number, telemetry device number, location of installation (including name of the State & District) shall be submitted to PESO on or before 15/01/2022 through email on email id: ndgawade@explosives.gov.in and asonbarse@explosives.gov.in.

This circular supercedes earlier circular dated 29/12/2021 on the subject matter.
