## **ORDER**

KSEBL, as a part of Ease of Doing Business reforms had extended the facility for revising connected load for all LT consumers based on self declaration as per BOs read as 3<sup>rd</sup> to 7<sup>th</sup> above, to regularise their connected load from 01.08.2019 upto 31.05.2021. The Scheme was reopened as per BO read as 8<sup>th</sup> above for a period upto 31.01.2022.

Due to lock down restrictions in connection with COVID-19 pandemic, several requests seeking extension of Scheme period were received from field officers, since consumers were unable to regularise connected load.

Considering the fact that the Scheme has attracted wide publicity and that if the consumers come forward to declare their connected load, it will aid KSEBL in planning for meeting the demand of the consumers, the Director (Distribution & IT) as per note read 9<sup>th</sup> above suggested that the above scheme period be extended for a period upto 31.03.2022.

Having considered the matter in detail, the Full Time Directors in its meeting held on 02/02/2022,

1. Resolved to accord sanction to extend the facility for revising connected load for all LT consumers based on self declaration announced vide BO dated 26/10/2021, for the period till **31/03/2022**.

2. Further resolved to authorize the Public Relations Officer to give wide publicity for the same.
