Sub: "PREFERENTIAL PURCHASE INCENTIVES FOR MICRO AND SMALL ENTERPRISES SCHEME, 2022".

- 1. Short title and commencement.— i. This scheme shall be called as the "Preferential Purchase Incentives for Micro and Small Enterprises Scheme, 2022".
- ii. It shall come in force from the date of its publication in the Official Gazette, and shall remain in force for a period of five years.
- 2. Introduction.— i. To give effect to the provisions of the Industrial Policy, 2003, the Government of Goa has decided to formulate a "Preferential Purchase Incentives for Micro and Small Enterprises Scheme, 2022" in supersession of "Preferential Purchase Incentives for Micro and Small Enterprises Scheme, 2008".
- 3. Objectives.— i. This scheme is intended to encourage and give boost to Micro and Small Scale Enterprise Sector and needs to be complied with utmost care. Noncompliance of provisions of this scheme shall be viewed seriously and the officer concerned shall be personally held liable.

- 4. Eligibility.— i. Only those Micro and Small-Scale Enterprises in manufacturing and service sector, situated with their units in Goa, having Udyam registration with Directorate of Industries, Trade & Commerce shall be eligible for the benefit under this scheme. The definition of Micro and Small Enterprise shall be as per the MSMED Act in force at the time of implementation of the scheme. The units shall possess the Goa State Pollution Control Board's consent to operate/registration, as applicable.
- ii. The benefits of the scheme shall not be applicable where the bidders are only suppliers/traders/retailers of goods.
- iii. The bidding micro/small enterprise shall be considered for benefit under the scheme only if the enterprise is the manufacturer//service provider of the item that is tendered, as per the verification certificate issued by the District Industries Centre.
- iv. In case the tender is for more than one items, then the bidding MSE should be the manufacturer of at least 50% of the items (in value). The remaining products shall be sourced by the bidding MSE preferably from any MSME in Goa.
- v. In case of submission of false information, the unit shall be barred from being eligible for the scheme for a period of five years. The promoter of the unit shall also be barred from the benefits under this scheme, if bidding from any other unit/any other name.
- 5. Benefits.— Under this scheme the eligible units shall be given special treatment in any tender floated by Government Department/Autonomous Bodies/Corporations/Semi-Government Departments or any purchases made by them, as under:
  - i. Eligible units shall be allowed to match to lowest tender price floated by noneligible units provided its quoted price is within 15% of lowest quoted price by noneligible units.

Explanation: (a) In case of more than one eligible units falling within the range, the lowest one shall be preferred.

- ii. The concerned Departments shall ensure that the purchase price shall not exceed the MRP of goods wherever applicable.
- iii. The tender documents shall be supplied to Micro and Small Enterprises at the rate of maximum upto Rs. 500/-.
- iv. Earnest money shall be required to be deposited and the same shall be to the maximum Rs. 5,000/-.
  - v. No other security deposit is required.
- vi. Priority in payment shall be ensured to Micro and Small Enterprises and the payment shall be effected by the concerned Department to the unit within 60 days of submission of final invoice by the unit on delivery of goods or completion of tendered work, failing which, the Department shall be liable to pay an interest at the rate of 0.75% per month.
- 6. Other condition.— i. For the purpose of availing benefit under this scheme, the Micro and Small Enterprises shall be required to match standard of quality as required by the State Government Department and be liable for all manufacturing guarantees, warranties, servicing as applicable for the item.
- ii. The scheme shall be applicable even for purchase of computer hardware and other electronic items except in cases of purchases of Education Department, under this scheme.
- 7. Method of application for benefits.— i. All the MSEs willing to take benefit under this scheme shall file an application to the General Manager (DIC) in the format appended as Annexure A. After due diligent examination, General Manager (DIC) shall issue verification certificate for the same stating that the enterprise is eligible for preference under this notification for the products mentioned therein. The Standard Operating Procedure to issue this certificate shall be designed by the Directorate of Industries, Trade and Commerce. The application for grant of certificate for availing this scheme shall be disposed of within a period of 30 days from the date of application. The certificate shall remain valid for five years from the date of issue.

- ii. The applicant shall submit a copy of this certificate along with the bid where preference is sought under this scheme.
- iii. The list of such certificates issued shall be made available in the public domain for the benefit of all the procuring departments.
  - 8. Relaxation.— The Government may relax any or all the conditions under this scheme.
- 9. Interpretation.— If any question arises, regarding interpretation of any clause, word, expression of this scheme the decision shall lie with the Government, which shall be final and binding on all concerned.
- 10. Removal of difficulties.— All issues relating to the eligibility, definition, operationalization or issues on account of new situation arising due to certain circumstances, not envisaged at the time of formulation of this scheme or the target schemes, would be resolved by the Government of Goa.
