KERALA WATER AUTHORITY—HIKING OF THE EXISTING DEPOSIT AMOUNT FOR CASUAL CONNECTIONS AND DEPOSIT LIMIT—PERMISSION GRANTED—ORDERS ISSUED.

ORDER

As per the letter read above, M.D. KWA has furnished a proposal for amending Rules 5 (e) of The Kerala Water Authority (Water Supply) Regulations, 1991 with the permission of the Government of Kerala as per item No. IX (4) of the 420th Board Meeting of the Kerala Water Authority dated 23-7-2021. The amendment intended to increase the existing deposit amount for casual connections to ₹ 105 per square meter according to 5% tariff increase and deposit limit from ₹ 20,000 to ₹ 3,00,000, with effect from 1-4-2021.

Government have examined the matter in detail and are pleased to accord sanction to amend the Kerala Water Authority (Water Supply) Regulations 1991 by increasing the deposit amount of casual connections in Kerala Water Authority from ₹ 100 per square meter at present to 105 per square meter as per 5% tariff hike effective from 1-4-2021 and increase the deposit limit from ₹ 20,000 to ₹ 3,00,000.

In exercise of the powers conferred by clauses (h) and (i) of sub-section (2) of section 65 of the Kerala Water Supply and Sewerage Act, 1986 (Act 14 of 1986) and with the previous approval of the Government as required by sub-section (1) of the said section conveyed in G.O.(Ms.) No. 39/2022/WRD dated 16th June 2022, the Kerala Water Authority hereby make the following regulations further to amend the Kerala Water Authority (Water Supply) Regulations, 1991, namely:—

REGULATIONS

1. *Short title and commencement.*—(1) These regulations may be called The Kerala Water Authority (Water Supply) Amendment Regulations, 2022.

(2) They shall come into force at once.

2. *Amendment of the Regulations.*—In the Kerala Water Authority (Water Supply) Regulations, 1991, for Regulation 5 (e), the following regulation shall be substituted, namely:—

“Notwithstanding anything contained in the above regulations, applicants seeking casual connections shall deposit an amount equal to the cost of 2.5 Kilo litres of water for each square meter of the plinth area of the building proposed to be constructed at the premises at the rate of ₹ 105 per square meter subject to a maximum deposit limit of ₹ 3,00,000”.
