Sir/Madam,

Please refer to this office letters of even No. dated 20/06/2023, 17/07/2023, 20/07/2023 and 04.10.2023 wherein process of Aadhar seeding through OTP Based Authentication & Biometric Authentication were circulated in detail for information and necessary action by all the field offices.

In this regard, it is informed that ICT Branch (HQ) has recently made the following provisions/changes in application in order to speed up Aadhar Seeding:


1. AAA+ mobile app has been facilitated with a new feature for Aadhaar seeding and ABHA generation using face-authentication for the IP log-in. Using this facility, IP shall be able to seed Aadhaar for self and family using face-authentication. This facility is available to the user after the latest update which is already live on Google Play Store. The User Manual for the same is attached herewith for information and necessary action.
2. Proof of Concept (POC) of Biometric Authentication Device ATS300 (M/s Access Computertech Pvt. Ltd.) has been successfully conducted by ICT Branch and has been implemented in employer and ESIC Staff portal for Aadhar Seeding. It may also be used in addition to earlier approved devices for biometric authentication and seeding of aadhaar details of IPs and their family members.
3. Further, provision has been deployed in Branch Office login for "Aadhaar Seeding and ABHA Generation" of PDB/DB Beneficiary.

It may be noted that the above feature is in addition to existing OTP Based Authentication & Biometric Authentication and all three processes for Aadhar seeding

shall continue until further orders.

Therefore, all the field offices are requested to give wide publicity of this new feature in their jurisdiction to expedite the Aadhar Seeding of IPs and their family members and achieve the daily target fixed for their respective ROs/SROs.

Overview

- The Purpose of seeding the Aadhaar, it has been identified as a potent tool to facilitate various services based on biometric authentication of the person/citizen having Aadhaar number from UIDAI data base.
- Currently, Aadhaar seeding facility is available only in Insured Person login.
- The purpose/benefits of seeding the Aadhaar number and display the Aadhaar Status in ESIC Panchdeep Application are mentioned as below-
 - To prevent the fraudulent activities in financial transactions.
 - Aadhaar Status can be used to merge the contribution of duplicate Insured person.
 - Aadhaar Status can be used to perform the e-KYC; post e-KYC system will have the UIDAI verified demographic details of the beneficiaries.
 - Aadhaar Status can be used to authenticate the beneficiaries at the time-of-service delivery.
