NOTIFICATION

No. ECAB/SUPP/2023/15.- Whereas the draft the Assam Food Security (Amendment) Rules, 2023 which the Governor of Assam proposes to make, were published as required under sub-section(1) of section 40 of the National Food Security Act, 2013 (Central Act No. 20 of 2013) in the Assam Gazette, Extraordinary No. 555 dated 12th December, 2023 inviting objections or suggestions from all persons likely to be affected thereby, before the expiry of a period of 10(ten) days from the date of publication of the said notification in the Official Gazette.

And whereas no objections or suggestions received by the Governor in respect of the draft amendment rules before the expiry of the specified period.

Now, therefore, in exercise of the power conferred by sub-section (1) of section 40 of the National Food Security Act, 2013 (Central Act No. 20 of 2013), the Governor of Assam is hereby pleased to make the following rules having been published previously as mentioned hereinabove, in the manner hereinafter appearing, namely:-

Short title and
Commencement

- (1) These rules may be called the Assam Food Security (Amendment) Rules' 2023.
(2) They shall come into force on the date of their publication in the official Gazette.

Amendment of
Rule 4

- In the Principal Rules, in rule 4,-
(i) in sub-rule (1), after clause (q), the following new clause (r) shall be inserted, namely:-

"(r) State Government Muster Roll employees and Daily Wage Earners, Retired Grade-IV employees of Central and State Government and Contractual employees having annual family income of less than Rs. 4,00,000.00 (four lakhs)"

(ii) in sub-rule (2), clause (b) shall be omitted.
