No.Elec-2024/IR-II/PSCE/Hol/ 13874 Whereas the **Bye-elections to Legislative Assembly Constituencies of 04-Badrinath & 33-Manglaur of Uttrakhand and 34-Jalandhar West (SC) of Punjab is to be held on 10.07.2024 (Wednesday)**, as per the letter issued by Chief Electoral Officer, Haryana vide letter No. 130 (Public Holiday)/OS/Bye-Elec-2024/2AE-6732 Dated 28.06.2024.

And whereas, it is considered necessary to provide opportunity to those who are working in the state of Haryana and enrolled as voters in Legislative Assembly Constituencies of 04-Badrinath & 33-Manglaur of Uttrakhand and 34-Jalandhar West (SC) of Punjab to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes **“Wednesday” the 10.07.2024** to be the **holiday with wages** for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana for only those employees who are enrolled as voters in Legislative Assembly Constituencies of 04-Badrinath & 33-Manglaur of Uttrakhand and 34-Jalandhar West (SC) of Punjab to enable them to cast their votes.






