In exercise of power conferred under clause 13(3) of the Tea (Marketing) Control Order, 2003, the following directives are hereby issued for mandatory compliance by all Tea manufacturers.

1. In case of failure to carry out the direction, necessary action as per clause 5 (1) (d) of Tea (Marketing) Control Order, 2003 shall be initiated by the Board.

- 2. This Order is issued based on decision taken by the Board in its 237<sup>th</sup> Meeting held on 26-09-2018.
- 3. Gardens which have adopted pruning / other cultivation practices other than traditional method and expect early crop / as well as manufacturers of orthodox, green and specialty teas, may seek exemption from respective office of the Board. However, this order is issued well in advance to enable the tea gardens and tea factories to make plans accordingly
- 4. Board's Officers not below the rank of Assistant Director of Tea Development are authorized to issue exemption sought for the cases as stated under SI. No.3 above (if any), after due field verification with intimation to Head Office of the Board. While issuing such exemptions, the Officers shall take into account about the pruning practices, irrigation facilities availability, early rains which might lead to early flushing and flushing pattern including valid reason for delay in sorting of made tea.
- 5. Any request for exemption shall be disposed of within 5 working days from the date of receipt.
