Intra-State Deviation Settlement Mechanism consequent to CERC (*Deviation Settlement Mechanism and Related Matters*) Regulations, 2024

ORDER

(Date of Order: 13/09/2024)

- 1) Central Electricity Regulatory Commission (CERC) has notified *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024* which is to be made applicable from 16/09/2024. Further, Delhi SLDC vide its letter dated 30/08/2024 requested the Commission to issue necessary direction/ guidelines for implementation of the same at intra-state level.
- 2) Accordingly, taking note of the above request of Delhi SLDC, which has been entrusted with the responsibility, *inter-alia* for grid control and despatch of electricity within the State as per Section 32 of the Electricity Act, 2003, the officers of the Commission conducted meeting with all Pool participants and SLDC on 5/09/2024.
- 3) During the said meeting, salient features of *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024* were discussed and deliberated. Subsequently all Pool participants and SLDC have submitted their comments to the Commission.
- 4) The Commission, considering the inputs of Pool participants and SLDC, decides and directs as follows related to implementation of Intra-State Deviation Settlement Mechanism in consequence to *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024*:

a) Charges for Intra-State Deviation Settlement Mechanism

The Commission directs Delhi SLDC to consider the rates as prescribed in *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024*.

b) Over-drawl and Under-drawl limit for Intra-State Level

The Commission directs Delhi SLDC to consider the DISCOM wise Over-drawl/ Under-drawl limit as follows:

Delhi Distribution Licensees	Over-drawl/Under-drawl limit
1) TPDDL	29 MW
2) BRPL	41 MW
3) BYPL	21 MW
4) NDMC	10% of Schedule or 5 MW, whichever is lower
5) MES	10% of Schedule or 3 MW, whichever is lower
6) Northern Railway	10% of Schedule or 1 MW, whichever is lower

c) Settlement of Auxiliary power drawn by Generators in case of shut down, Start-up Power & Infirm Power

The Commission directs Delhi SLDC to implement the specific provisions of *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024* related to start-up power before the COD of a generating unit or for drawal of power to run the auxiliaries during the shut-down of a generating station or for infirm power.

d) Applicability of DSM on Waste to Energy Management Plant

The Commission directs Delhi SLDC to implement the specific provisions of *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024* related to Waste to Energy (WTE) Plants for those WTE Plants which are commissioned after 26/12/2022.

For the purpose of deviation settlement, Contract Rate defined in clause 3.1(j)(iii) of *CERC (Deviation Settlement Mechanism and Related Matters) Regulations, 2024* shall be applicable.

- 5) This Order shall come into force from 16/09/2024, accordingly the Order dated 26/12/2022 stands repealed to the extent provided in the Order only. This Order shall be applicable till further review/ modification as deemed fit.
- 6) Ordered accordingly.
