## **NOTIFICATION**

In exercise of the powers conferred by section 29 read with section 68 of the Telangana State Forest Act, 1967 (Act No.1 of 1967), the Government of Telangana hereby makes the following amendment to the Telangana Wood Based Industries (Regulation) Rules, 2022 issued vide G.O.Ms.No.69, Environment Forests Science & Technology (For.I) Department, Dt. 05.08.2022 as amended from time to time:

### **AMENDMENT**

In the Telangana wood Based Industries(Regulation) Rules, 2022 in Rule 11 for sub-Rule(9), the following shall be substituted, namely,

"(9) If the renewal fee along with late fee is not paid up to 31<sup>st</sup> December of the following year, the licence shall be deemed to have been lapsed and no request for renewal shall be entertained by any authority except State Level Committee (SLC).
