फोर्टिफाइड चावल (एफआर)-अनुलग्नक-1, फोर्टिफाइड चावल कर्नेल (एफआरके)-अनुलग्नक-2 और फोर्टिफाइड चावल कर्नेल के लिए विटामिन-मिनरल प्रीमिक्स (अनुलग्नक-3) में फोर्टिफिकेंट्स (आयरन, विटामिन बी12 और विटामिन बी9) का परीक्षण करने में सक्षम एफएसएसएआई अधिसूचित प्रयोगशालाओं की अनुमोदित सूची एफआर, एफआरके और एफआरके के लिए विटामिन-मिनरल प्रीमिक्स के नमूनों का विश्लेषण करने के उद्देश्य से संलग्न है। प्रयोगशालाएँ परीक्षण के लिए नमूनों को स्वीकार करेंगी यदि उनके पास वैध मान्यता स्थिति है।

3. यह आदेश इस मामले पर दिनांक 23.08.2024 के पिछले आदेश का स्थान लेता है।
