Draft Karnataka Electricity Regulatory Commission (Fee) Regulations, 2024. Preamble:

The Karnataka Electricity Regulatory Commission (KERC) according to Section 86(1) (g) read with Section 181 (2) (zp) of the Electricity Act,2003, vide Notification dated 19.08.2016 had issued KERC (Fee) Regulations, 2016.

Under the provisions of the Electricity Act, the Karnataka Electricity Regulatory Commission shall have to discharge various functions including issue of licences, determination of tariffs, adjudication of disputes between generators, Transmission and Distribution Licensees etc., review of its orders and various miscellaneous services.

The Commission notes that the Commission had issued Fee Regulations in 2016 and after the issue of said Regulations, the establishment costs of the Commission have increased substantially due to increase in rates of inflation resulting in escalation of Commission's recurring expenditure. Hence, the Commission has felt a need to revise the rates of existing fees.

The Commission, under the provisions of Section 86(1) (g) of the Electricity Act,2003 proposes to issue new Regulations prescribing levy of new rates of fees for the purpose of the discharge of its functions under the Electricity Act, 2003.

Accordingly, in exercise of the powers conferred on it under Section 86(1)(g) read with Section181(2) (zp) of the Electricity Act,2003 (Central Act No.36 of 2003), the Commission hereby notifies the draft KERC (Fee) Regulations,2024 for information of all the stakeholders. Notice is hereby given to the stakeholders and other interested persons that the said draft will be finalised after fifteen (15) days from the date of its publication in the official gazette. The Stakeholders and interested persons may file objections/ suggestions/ views on the proposed new draft Regulations within fifteen (15) days from the date of its publication to the Secretary of the Commission at the following address:

Draft Karnataka Electricity Regulatory Commission (Fee) Regulations, 2024.

1. Short title and commencement:

- (i) These Regulations may be called the "Karnataka Electricity Regulatory Commission (Fee) Regulations, 2024".
- (ii) They shall come into force from the date of their publication in the Karnataka Government Gazette.
- (iii) They shall extend to the whole of the State of Karnataka.

2. Definitions:

- (1) "Act" means the Electricity Act,2003 (Act of 2003);
- (2) "Commission" means the Karnataka Electricity Regulatory Commission;
- (3) "Licensee" means a person who has been granted a licence under section 14 of the Act;

- (4) "Generating Company" means any company or body corporate or association or body of individuals, whether incorporated or not, or artificial judicial person, which owns or operates or maintains a generating station;
- (5) "Trading "means purchase of electricity for resale thereof and the expression "trade" shall be construed accordingly;

In these Regulations, the words and expressions used shall bear the same meaning as in the Electricity Act, 2003 (the Act, in short) or other Regulations issued by the Commission or any other law for the time being in force.

3. Fee:

- (i) (a) Every petition, application, complaint shall be made to the Commission along with payment of stipulated fee specified in these Regulations. Several persons having similar but separate and distinct interest or cause of action in the matter of controversy or dispute involving common questions of law and facts may file a common petition but each Petitioner shall pay separate fee as specified in these Regulations.
- (b) Every application for grant of licence or exemption of licence under section 14 of the Act shall be accompanied by such fee as may be prescribed by the State Government under Section 15 read with Section 180 (2) (a) of the Act.
 - Provided that till such time the fee is prescribed by the State Government, the application for grant of licence or exemption of licence shall be accompanied by a processing fee of Rs.50,000/-
- (ii) Every Licensee shall pay the Annual Licence fee as may be specified from time to time, in these Regulations, within the time specified in the KERC (Licensing) Regulations, 2004. Late payment of fee will attract penal interest as may be decided by the Commission:
- (iii) The fee payable to the Commission, as specified in these Regulations may be paid by means of a Bank draft or Banker's cheque, drawn in favour of the Secretary, Karnataka Electricity Regulatory Commission, payable at Bengaluru.

Provided that, for amounts not exceeding Rs. 5,000/-, the Commission may accept cash payments.

Provided further that, the Fee may be paid through Real Time Gross Settlement (RTGS) or through National Electronic Fund Transfer (NEFT) for amount above Rs. 25,000/- and persons making payment of fee through RTGS/NEFT shall submit the details of remittance as per the Form-I appended to these Regulations

- (vi) The Commission may, in appropriate cases, by order in writing, waive or reduce the amount of fee payable under these Regulations.
- (vii) Where any dispute is settled between the parties to a petition before commencement of effective hearing or arguments on merits or where any petition is withdrawn by the party /parties before admission of the petition, fifty per cent of the fee shall be ordered to be refunded to the party/ parties by whom the fee is paid.

Note: The fee at SI. Nos. 4 and 5 above shall be paid by the concerned licensees even in case the Commission initiates Suo- motu proceedings for determination of tariff.

5. Power to amend:

The Commission may from time to time add, vary, alter, modify or amend any provision of these regulations after following the necessary procedure.

6. Repeal:

- (1) The Karnataka Electricity Regulatory Commission (Fee) Regulations, 2016, as amended from time to time, is hereby repealed.
- (2) Notwithstanding such repeal, anything done or purported to have been done under the repealed regulations shall be deemed to have been done or purported to have been done under these regulations.

7. Power to Remove Difficulties:

If any difficulty arises in giving effect to any of the provisions of these Regulations, the Commission may, by general or special order, pass appropriate orders, not being inconsistent with the provisions of the Act, which appears it to be necessary or expedient for the purpose of removing the difficulties.

8. Interpretation:

The decision of the Commission regarding the interpretation of these Regulations shall be final and binding.
