**NOTIFICATION**

The 7<sup>th</sup> December, 2017

No.8/367/2017-3P - The Governor of Haryana is pleased to approve the following scheme for providing monthly pension of Rs.10,000/- to the accredited media persons of daily, evening, weekly, fortnightly, monthly newspapers, news agencies, Radio stations, news channels, above the age of 60 years.

The following will be eligibility criteria and terms and conditions of the scheme :

**A) Eligibility Criteria :**

1. The accredited media persons of daily, evening, weekly, fortnightly, monthly newspapers, news agencies, Radio stations, news channels with atleast 20 years of experience in the field of journalism and above the age of 60 years.
2. The media person should have been accredited with the Information, Public Relations & Languages Department, Haryana for atleast five years.

**B) Terms & Conditions :**

- i) The beneficiary media person will have to open an Aadhar linked savings bank account in any nationalised bank for depositing the amount of pension in their bank accounts and have to give a certificate in the month of January every year to this effect.
- ii) There should be no criminal proceedings pending against the beneficiary media person.
- iii) The pension under this scheme will be discontinued in case of registration of any criminal case against the beneficiary media person at any time or the conduct of the media person is found against the set principles/ethics of journalism.
- iv) The media person, getting pension or honorarium of any kind from any other State Government or news organisation will also be eligible. However, if an otherwise eligible media person is getting pension from any other State Government of an amount less than Rs.10,000/- per month, the entitlement of pension under this scheme would be reduced by that amount.

**C) Committee to decide and make recommendations in each individual case :**

A 5-member Committee will be constituted to review each application and give its recommendations for grant of pension. However, in all cases, the decision of the Government shall be final.

**D) General :**

- a) Under this scheme, a monthly pension of Rs.10,000/- will be given to the eligible media persons.
- b) The Administrative Secretary of Information, Public Relations & Languages Department, Haryana will be competent to accord sanction under this scheme.
- c) The expenditure under this scheme will be borne by the Samvad Society, for which the department will provide him grant-in-aid. After sanction by the Administrative Secretary of this department, the amount of pension will be deposited in the bank account of beneficiary media person by the Samvad Society.
- d) In case of demise of beneficiary media person, the monthly pension will continue to be given to his/her spouse (wife or husband, as the case may be), in case he/she is not getting any salary/wages/pension/any other regular financial assistance from any organisation or the State Government.
- e) This scheme will come into effect from the date of notification.

**E) Submission of applications :**

The prescribed proforma for applying under the scheme will be available on a website and as far as possible, the media persons should apply on-line for grant of pension.

हरियाणा सरकार

**क्रमांक 8/367/2017-3पी.**— हरियाणा के राज्यपाल ने 60 वर्ष से अधिक आयु के मीडियाकर्मियों के लिए पेंशन योजना में निम्नलिखित संशोधन किया है।

- (1) मासिक पेंशन की राशि को 10,000/- रुपये से बढ़ाकर 15,000/- रुपये किया है।
- (2) इस योजना के तहत हरियाणा राज्य में वेतन/पारिश्रमिक के आधार पर पत्रकारिता के क्षेत्र में कम से कम 20 वर्षों का अनुभव रखने वाले 60 वर्ष से अधिक आयु के मीडियाकर्मियों मासिक पेंशन के पात्र हैं। मीडियाकर्मियों को कम से कम पांच वर्षों के लिए सूचना, जनसंपर्क एवं भाषा विभाग, हरियाणा से मान्यता प्राप्त होना चाहिए।
- (3) जो पेंशनभोगी हरियाणा के निवासी हैं और उनके पास परिवार पहचान पत्र आईडी है उन्हें हर साल जीवन प्रमाण पत्र जमा करने की आवश्यकता नहीं होगी।
- (4) किसी लाभार्थी मीडियाकर्मियों के खिलाफ कोई आपराधिक मामला दर्ज होने या मीडियाकर्मियों का आचरण पत्रकारिता के निर्धारित सिद्धांतों/नैतिकता के विपरीत पाए जाने पर इस योजना के तहत उसकी पेंशन बंद कर दी जाएगी।
- (5) किसी अन्य राज्य सरकार या समाचार संगठन से किसी भी प्रकार की पेंशन या मानदेय प्राप्त करने वाला मीडियाकर्मियों भी पात्र होगा। हालांकि, यदि कोई पात्र मीडियाकर्मियों हरियाणा राज्य/केंद्र सरकार या किसी अन्य राज्य सरकार/सार्वजनिक क्षेत्र के उपक्रम से 15,000/- रुपये प्रति माह से कम राशि की पेंशन प्राप्त कर रहा है, तो इस योजना के तहत पेंशन की पात्रता उक्त संस्थानों से मिलने वाली मासिक पेंशन राशि से उतनी ही राशि कम हो जाएगी। इस योजना के तहत पेंशन प्राप्तकर्ता वृद्धावस्था सम्मान भत्ता प्राप्त करने के लिए अयोग्य होगा।
- (6) पेंशन चाहने वाले मीडियाकर्मियों को इस योजना के लिए निर्धारित प्रोफार्मा में आवेदन करना होगा। इसमें राज्य स्तर के पत्रकार सीधे विभाग के राज्य मुख्यालय में आवेदन करेंगे, जबकि जिला, उपमंडल और ब्लॉक स्तर के पत्रकार संबंधित जिला सूचना एवं जन सम्पर्क अधिकारी के माध्यम से आवेदन करेंगे। राष्ट्रीय राजधानी क्षेत्र (एनसीटी), नई दिल्ली में स्थित पात्र मीडियाकर्मियों सयुक्त निदेशक/उपनिदेशक या सूचना, जनसंपर्क एवं भाषा विभाग, हरियाणा, नई दिल्ली के प्रभारी के माध्यम से आवेदन करेंगे। संबंधित प्रभारी अपनी टिप्पणियों के साथ पूर्ण रूप से भरा हुआ आवेदन सूचना, जनसंपर्क एवं भाषा विभाग के महानिदेशक/निदेशक को अग्रेषित करेंगे। पेंशन चाहने वाला आवेदक अगर हरियाणा का निवासी है तो उसको आधार कार्ड और

परिवार पहचान पत्र की फोटो प्रतियां जमा करनी होंगी और अगर पात्र आवेदक हरियाणा का निवासी नहीं है तो उसको परिवार पहचान पत्र (अस्थायी) के साथ आधार कार्ड की प्रति जमा करनी होगी। योजना के तहत लाभ प्राप्त करने वाले मीडिया कर्मियों के लिए परिवार पहचान पत्र अनिवार्य होगा।

- (7) योजना के किसी भी खंड की व्याख्या से उत्पन्न किसी भी विवाद की स्थिति में राज्य सरकार का निर्णय अंतिम होगा।
- (8) लाभार्थी मीडियाकर्मी के निधन के मामले में, मासिक पेंशन राशि का आधा हिस्सा उसके जीवनसाथी (पत्नी या पति, जैसा भी मामला हो) को दिया जाता रहेगा, अगर उसे किसी अन्य संगठन या केंद्र/ राज्य सरकार/ सार्वजनिक क्षेत्र के उपक्रमों से कोई वेतन/ अनुबंध शुल्क/ पेंशन/ पारिश्रमिक नहीं मिल रहा है
- (9) यह योजना अधिसूचना की तिथि से लागू होगी।
- (10) परिवार पहचान पत्र के अनुसार प्रति परिवार आईडी का केवल एक सदस्य मासिक पेंशन के अनुदान के लिए पात्र होगा।
- (11) पेंशन योजना में निर्धारित अन्य नियम और शर्तें वही रहेंगी जो सरकार के यादि क्रमांक 8/367/2017-3पी, दिनांक 07 दिसंबर, 2017 द्वारा अधिसूचित की गई थी।

#### Notification

**No. 8/367/2017-3P.**— the Governor of Haryana is pleased to make the following amendments in the pension scheme for media persons above the age of 60 years.

- (1) “To increase the amount of monthly pension from Rs.10,000/- to Rs.15,000/-.”
- (2) The media persons above the age of 60 years with atleast 20 years of experience in the field of journalism on salary/ remuneration basis in the state of Haryana are entitled for monthly pension under this scheme. The media person should have been accredited with the Information, Public Relations & Languages Department, Haryana for atleast 5 years.
- (3) Pensioners who are resident of Haryana and possess a Parivar Pehchan Patra ID shall not be required to submit a life certificate every year.
- (4) The pension under this scheme will be discontinued in case of registration of any criminal case against the beneficiary media person at any time or the conduct of the media person is found against the set principles/ethics of journalism.
- (5) The media person getting pension or honorarium of any kind from any other State Government or news organization will also be eligible. However, if an otherwise eligible media person is getting pension from State of Haryana/Central Government or any other State Government/Public Sector Undertaking of an amount less than Rs.15,000/- per month, the entitlement of pension under this scheme would be reduced by that amount. The recipient shall be ineligible to receive the Old Age Samman Allowance.
- (6) The media person for seeking Pension shall have to apply in the prescribed proforma of the scheme for which the State level journalists shall apply directly to the State Headquarter, whereas, district, sub division and block level journalists shall apply through the concerned District Information and Public Relations Officers of their respective districts and those based at National Capital Territory(NCT), New Delhi through JD/DD or Incharge of Information, Public Relations and Languages Department, Haryana, New Delhi and concerned incharges shall forward such applications complete in all respects alongwith their comments to the DGIPRL/DIPRL. Applicants seeking Pension shall have to submit photo copies of Aadhar Card and Parivar Pehchan Patra in the case of resident of Haryana and non-resident of Haryana shall submit copy of Aadhar card along with Parivar Pehchan Patra (temporary). Parivar Pehchan Patra shall be mandatory for media persons receiving benefits under the scheme.

- (7) In the event of any dispute arising out of interpretation of any of the clauses of the scheme the decision of the State Government shall be final.
- (8) In case of demise of beneficiary media person, half of the monthly pension amount will continue to be given to his/her spouse (wife or husband, as the case may be), in case he/she is not getting any salary/contract fee/pension/remuneration from any other organization or the Central/State Government/Public Sector Undertakings.
- (9) This scheme will come into effect from the date of notification.
- (10) Only one member per family id as per Parivar Pehchan Patra shall be eligible for grant of monthly pension.
- (11) The other terms and conditions laid down in the pension scheme will remain the same as notified vide Government memo no.8/367/2017-3P, dated December 07, 2017.
