## **NOTIFICATION**

In exercise of the powers conferred by Section 14 of the Unorganised Workers Social Security Act, 2008 (Central Act No.33 of 2008), the Government of Karnataka, hereby makes the following rules further to amend Unorganised Workers Social Security (Karnataka) Rules 2009, namely:-

### **RULES**

- 1. **Title and Commencement.-** (1) These Rules may be called the "Unorganised Workers Social Security (Karnataka) (Amendment) Rules, 2024".
- (2) They shall come into force from the date of their publication in the Official Gazette.
- **2. Insertion of new rule 13.-** In the Unorganised Workers Social Security (Karnataka) Rules 2009, (hereinafter referred to as the said rules), after rule 12, the following shall be inserted namely:-
  - **"13. Annual Report.-** An annual report in Form IV on the working of the Board during preceding ending on 31 March shall be laid, as soon as may be, after it is made, before each House of the State Legislature, after 1<sup>st</sup> day of April every year and not later than 31<sup>st</sup> day of December, along with audited copies of accounts and the auditor's report."
  - **3. Insertion of new Form IV.-** In the said rules, after Form III, the following shall be inserted namely:-

#### "Form IV

(See Rule 13)

#### ANNUAL REPORT

Annual Report should contain details of Annual Budget allocated, Expenditure details, Schemes description in short, Schemes progress (Both Financial and Physical) and other activities taken by the Board."

Audit Report should contain Balance Sheet, Income and Expenditure and Audit Notes."
