**G.S.R.90** .-In exercise of the powers conferred by clause (a) of sub-section (2) of section 28, clause (a) of sub-section (2) of section 38 and clause (b) of sub-section (2) section 65 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), the State Government proposes to make the following amendments in the Rajasthan Motor Vehicles Rules, 1990. The following draft rules are hereby published as required by sub-section (1) of section 212 of the said Act, for information of the persons likely to be affected thereby and notice is hereby given to them that the said draft would be taken into consideration after the expiry of a period of fifteen days from the date on which the copies of this notification as published in the Official Gazette are made available to the public.

Any objection or suggestion which may be received from any person with respect to the said draft rules before the expiry of the period as specified above shall be considered by the State Government.

#### **Draft Rules**

- **1. Short title and commencement.-** (1) These rules may be called the Rajasthan Motor Vehicles (Third Draft Amendment) Rules, 2024.
- (2) They shall come into force on the date of their final publication in the Official Gazette.
- **2. Amendment of rule 2.1.-** In rule 2.1 of the Rajasthan Motor Vehicles Rules, 1990, hereinafter referred to as the said rules,-
  - (i) for the existing punctuation mark ".", appearing at the end, the punctuation mark ":" shall be substituted; and
  - (ii) the following proviso shall be added, namely:-

"Provided that in case where application for services specified by the State Government, from time to time, in relation to Driving Licence is received and distributed electronically by the faceless management system, the authority specified above to whom application is assigned by the such system shall be the Licensing Authority for that purpose."

### 3. Amendment of rule 3.1.-In rule 3.1 of the said rules,-

- (i) for the existing punctuation mark ".", appearing at the end, the punctuation mark ":" shall be substituted; and
- (ii) the following proviso shall be added, namely:-

"Provided that in case where application for services specified by the State Government, from time to time, in relation to Conductor's Licence is received and distributed electronically by the faceless management system, the authority specified above to whom application is assigned by the such system shall be the Licensing Authority for that purpose."

## **4. Amendment of rule 4.1.-**In sub-rule (1) of rule 4.1 of the said rules,-

- (i) for the existing punctuation mark ".", appearing at the end, the punctuation mark ":" shall be substituted; and
- (ii) the following proviso shall be added, namely:-

"Provided that in case where application for services specified by the State Government, from time to time, in relation to Registration of Vehicle is received and distributed electronically by the faceless management system, the authority specified above to whom application is assigned by the such system shall be the Registering Authority for that purpose."
